Notice of Solicitation of Candidates

2 Council Seats Open- 2-year Term for each seat.

Procedure for declaring candidacy is as follows:

- (a) Each candidate for Town Councilman shall notify the Town Manager in writing of his candidacy, P.O. Box 216, Greenwood, DE 19950.
- (b) All notifications of candidacy shall be filed with the Town Manager not later than five o'clock in the afternoon, prevailing time, on Friday, December 14, 2018.
- (c) Such notification of candidacy shall be upon a suitable form or blank furnished by The Town of Greenwood, which said statement shall be dated, signed by the candidate and witnessed by at least 2 residents of the Town.

Qualifications for members of Town Council:

- (a) Each member shall be at least twenty-one (21) years of age.
- (b) Each member shall be a citizen of the United States and of the State of Delaware and a bona fide resident of the Town of Greenwood.
- (c) Each of the qualifications for members of the Town Council shall be continuing qualifications to hold office and the failure of any member of the Town Council to have any of the qualifications required by this Section 5 of the Town Charter during his term of office shall create a vacancy in the office.
