CODE ENFORCEMENT UPDATE:

THE CODE ENFORCEMENT OFFICER WILL BE MAKING ROUTINE INSPECTIONS FOR CODE VIOLATIONS. BELOW ARE FREQUENTLY ASKED QUESTIONS CONCERNING CODE ENFORCEMENT:

- Q. WHERE CAN I READ THE ORDINANCES FOR THE TOWN THAT DESCRIBE WHAT IS A CODE VIOLATION?

- Q. IS THE CODE ENFORCMENT OFFICER ALLOWED ON MY PROPERTY?
- A. THE TOWN CODE ALLOWS FOR THE CODE ENFORCEMENT OFFICER TO ENTER ANY PROPERTY THAT HAS A CODE VIOLATION IN ORDER TO OBTAIN THE CORRECT INFORMATION, DOCUMENT AND PHOTOGRAPH FOR EVIDENCE AND POST THE VIOLATION.
