Town Council Meeting Minutes
Wednesday, October 12, 2022

Call to Order

Mayor Donovan called the meeting to order at 6:30 p.m.

Councilman and Officials Present

Executive Session

At 6:30 p.m., entered Executive Session with a motion by Councilman Moran, Seconded by Vice-Mayor Reed. CARRIED Unanimously.

At 6:39 p.m., returned to Open Session with a motion by Councilman Torbert, Seconded by Vice-Mayor Reed. CARRIED Unanimously. No action taken.

Approval of Minutes

Motion by Vice-Mayor Reed, Seconded by Councilman Moran, to approve the Minutes of the September 21, 2022, Town Council Meeting. CARRIED Unanimously.

Police Report

Chief Thomas presented his report and noted that he and Corporal Willey are wearing pink tees under their uniforms in support of breast cancer awareness month.

Town Manager Report

1. Manager Todd stated that there a few projects being submitted to Planning & Zoning, including Bascio Bakery, Milford Housing, and the VFW Enhancement Center.
2. Water tower painting is scheduled to begin this month.
3. A handicapped accessible picnic table for the playground pavilion has been ordered.
4. We have 14 entries for the Christmas Parade so far. Corporal Willey will be handling traffic control.
5. Chief and Mrs. Todd had a zoom meeting with a representative regarding a better, more reasonably priced option for employee health insurance.
6. The water meter project is nearing completion.
7. There are some repairs needed for the roof and ductwork on the police side of Town Hall. We have received some estimates and are proceeding with some of the work.
8. Trick-or-treat and the Greenwood United Methodist Church's Trunk-or-Treat will be held October 31 from 6-8 p.m.

Old Business

1. After some discussion, Councilwoman Jones made a motion to accept the 2023 Operating Budget. Seconded by Vice-Mayor Reed. CARRIED Unanimously.
2. First reading of **Ordinance C5A: An Ordinance repealing in its entirety and replacing Ordinance C-5 establishing procedures for absentee voting in the annual municipal election and providing penalties for violations thereof.** The Mayor read a synopsis. This ordinance is sponsored by Councilman Moran.
3. First reading of **Ordinance C14: An Ordinance establishing a voter registration**

program for municipal elections in the Town of Greenwood. The Mayor read a synopsis. This ordinance is sponsored by Councilman Torbert.

New Business

1. At the request of Matt Taylor, current President of the Woodbridge Little League, there was some discussion about the use of the Greenwood ballpark. Tammy Lecates, minor league girls' softball coach and prior board member, acted as a spokesperson for WLL and coach Tim Uber spoke for the Diamond State Ducks. It was suggested that the Little League and the Ducks have a meeting and report back next month.
2. Town of Greenwood Resolution 2022-05: A Resolution establishing the time and days of regular Council meetings. Councilwoman Jones made a motion to accept the resolution. Seconded by Vice-Mayor Reed. CARRIED Unanimously.
3. Town of Greenwood Resolution 2022-06: A Resolution replacing Town of Greenwood Official Zoning Map. Vice-Mayor Reed made a motion to accept the resolution. Seconded by Councilwoman Jones. CARRIED Unanimously.
