

**Town of Greenwood**  
**Town Council Meeting Minutes**  
**Wednesday, January 11, 2023**

**Call to Order**

Mayor Donovan opened the meeting with the Pledge of Allegiance at 6:30 p.m.

**Approval of Minutes**

December 14, 2022, Town Council Meeting. Motion to approve minutes by Vice-Mayor Reed, Seconded by Councilwoman Jones. APPROVED Unanimously.

December 27, 2022, Special Town Council Meeting. Motion to approve minutes by Councilman Torbert, Seconded by Councilwoman Jones. APPROVED Unanimously.

**Police Report**

Chief Thomas stated that a job offer from Greenwood P.D. was accepted by Billy Thomas. His first official day as Sergeant with Greenwood Police Department will be February 6.

**Town Manager Report**

Ms. Todd gave a verbal report which included:

- Town Hall renovations are nearly done.
- Milford Housing received final approval from P&Z for 17 homes to be built in the Cove. Groundbreaking is expected this spring.
- Election for 2 council seats is January 21<sup>st</sup>. There are 3 candidates. We are having a “meet the candidates” night at the VFW January 17 at 6:30p.m.
- Property tax bills for 2023 have been mailed out.
- The Greenwood VFW is taking the lead on the “Hometown Heroes” project. Their goal is to have the first batch of banners up by Memorial Day.

Councilman Reed asked the status of the audit, to which Ms. Todd replied that the pages that the other auditor took out have been put back in, she will email the file, and they are going to do two years at one time.
