Call to Order

Town Manager Report

- 1. Sheriff sale update: most properties paid up prior to the sale, but the property at 200 Governors sold for \$45,000.00, 107 N. First didn't receive any bids, and 8 Beaver will be sold in June by the County.
- 2. Our Farmer's Market will be held this Saturday from 8-1.
- 3. We've begun our "Wall of Heroes". We now have 9 veteran's photos for the wall.
- 4. Delaware Rural Water completed our CCR (Consumer Confidence Report). We had no violations.

Old Business

1. There was more discussion regarding revisions to the Employee Handbook. Vice-Mayor Reed made a Motion to pay all Town employees double time for holidays instead of time and a half. Motion died for lack of a Second. Motion made by Vice-Mayor Reed, Seconded by Councilman Moran to cap vacation time at 5 weeks after 15 years of service instead of 20 years. CARRIED by Unanimous Vote. Motion made by Councilman Moran to accept the Handbook as written with changes that were discussed here, Seconded by Councilwoman Jones. CARRIED by Unanimous Vote.

- 2. Mayor Donovan asked the Council to review some Ordinances that can then be passed on to Manager Todd for revision by the Town's lawyer.
- 3. Chief Thomas made a pay increase & sign on bonus proposal to help with recruiting another officer. Motion made to approve by Councilman Moran, Seconded by Vice-Mayor Reed. CARRIED by Unanimous Vote.
