**COUNCIL and STAFF PRESENT:**

Mayor Branden Cessna, Vice Mayor Donnie Donovan, Secretary Dan Nelson, Councilor Randy Willey, Acting Town Manager Rhiannon Slater, Clerk Carolyn Chisenhall. Absent: Councilor A.J. Massey.

**CALL TO ORDER:**

Mr. Cessna opened the meeting at 6:33 pm with the Pledge of Allegiance.
